Release, Waiver, Hold Harmless, and Assumption of Risk

In consideration for being permitted by MyOutdoorJoy, LLC to participate in any class, or event (hereinafter "Activity") the undersigned agrees as follows:

1. I, the undersigned, as participant, or as parent or legal guardian of the child listed on this form, hereby assume full responsibility for all risk, known and unknown of injury or loss which may result from my or my child's participation in any Activity offered by MyOutdoorJoy, LLC and hereby agree to hold harmless, release and forever discharge MyOutdoorJoy, LLC, its officers, directors, agents and employees and their representatives, from any and all claims and demands whatsoever which the undersigned, any third party and their representatives or any person acting under their behalf have, or may have, against MyOutdoorJoy, LLC by reason of any accident, illness, injury, or death to any person or persons, or damage to, loss of or destruction of property arising or resulting directly or indirectly from my or my child's participation in the aforementioned activity, and occurring during said participation, or anytime subsequent thereto regardless of whether said claims or demands arise out of negligence on the part of MyOutdoorJoy, LLC or its leadership, staff, agents or employees. The terms of this release shall serve as a release and assumption of risk for myself, my child, heirs, executives, administrators, and for all of my family members.
2. I understand and acknowledge that any Activity may expose me and/or guests to risks including, but not limited to, bodily injury and damage to my own property or the property of others.
3. I understand that MyOutdoorJoy, LLC does not provide medical, travel, hazard, property or Activity insurance coverage for participants or guests in any activities. I assume responsibility for providing my own insurance.
4. I hereby state that I am in sufficient physical condition to participate in this Activity. I understand that a determination of my ability to participate in the Activity should be made by my physician if necessary. I further understand that treatment for any medical problems I may suffer is my responsibility and will be paid by me and/or covered by my insurance.
5. **I understand and acknowledge that if I am diagnosed with COVID-19 or become sick with any communicable disease, MyOutdoorJoy, LLC will not be responsible for adjusting my travel and lodging arrangements or paying for any quarantine or isolation arrangements (housing, food, other related expenses).**
6. In consideration of the opportunity to participate in this Activity, I have and do hereby indemnify, release, and will hold harmless MyOutdoorJoy, LLC and all its officers, employees, staff and agents from any and all liability, actions, causes of action, debts, claims and demands of every kind and nature whatsoever, and specifically including any claim for negligence or negligent acts, which I now have or which may arise out of or in connection with my participation in this Activity or in connection with any independent activities or travel that I choose to undertake while traveling during the Activity. The terms hereof shall serve as a release, indemnification, and assumption of risk for my heirs, executors, and administrators and for all members of my family, including any minors accompanying me.
7. **I recognize that this Release means I am giving up, among other things, rights to sue MyOutdoorJoy, LLC and their respective officers, staff, employees, and agents for injuries, damages, or losses I may incur during my participation in the Activity. I also understand that this Release binds my heirs, executors, administrators, and assigns, as well as myself.**
8. **Publicity Permission.** I am aware that the staff or others sometimes capture photographs, quotes, or other impressions or recordings of participants and share them with MyOutdoorJoy, LLC for use in a variety of ways, such as (but not limited to) in the newsletter, webpages, social media of MyOutdoorJoy, LLC or its allies (and Minor Participant, if any) agree not to restrict or condition such use in any way.
9. I understand that if a situation arises in which I require medical attention, I hereby consent to MyOutdoorJoy, LLC or its agents notifying my emergency contact and authorizing emergency medical care, treatment and transportation to a medical facility for me (or Minor participant, if any), if I am incapacitated or unable to make my own decision.

10. I understand that if I am asked to leave the Activity at the sole discretion of the Activity leader or Management of MyOutdoorJoy, LLC, I will be responsible for any and all cost, including without limitation my own travel costs and for any costs incurred by my participation in this Activity, and MyOutdoorJoy, LLC shall bear no responsibility or liability for my return travel. I further understand that if I leave or am excluded from any Activity for any reason there will be no refund of fees paid or expenses incurred by MyOutdoorJoy, LLC.

No representations, statements, or inducements, oral or written, apart from the foregoing written statement, have been made.
